





6. Bank Guarantee should be issued from commercial Bank, which is valid from Nepal Rastra Bank.
7. Bids received after the deadline of the submission will be rejected. Bids received by the above mentioned deadline shall be opened physically in the presence of the Bidders representatives who choose to attend at the address above at 14:00 Hours on **16 days from the first date of publication.**
8. If the last day for purchasing and submission falls on a government holiday then the next working day shall be considered as the last day.
9. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
